## Instructions for getting your forms in LoLA:

From LDCC Homepage www.ladelta.edu

Log onto LOLA – with your username and password

Under Self Service BANNER - click on FINANCIAL AID

Under Financial Aid Links-Click on Louisiana Delta Community College

Select the 2023-2024 Award Year from the drop down and view your requirements

"Unsatisfied Requirements" will be displayed. Click on forms requested and a PDF form(s) should display

You must <u>first</u> save the PDF fillable form(s) on your desktop, laptop, or phone. Next, complete, sign (student and parent if needed; you may also sign with a digital signature), and upload them to the "Financial Aid Document Upload" Portal at the following link:
